BY ENGAGING MULTIPLE STAKEHOLDERS FROM VA, PHARMA, AND PATIENT ADVOCACY GROUPS, ACT HAS BEEN ABLE TO IDENTIFY BARRIERS AND PROPOSE NEW PROCEDURES TO STREAMLINE OPERATIONS. THE PRP WILL SHEPHERD TRIALS THROUGH THE START-UP PROCESS (FROM INITIAL CONTACT THROUGH IRB APPROVAL), PROVIDE EDUCATION REGARDING VA PROCEDURE, AND SERVE AS A CLEARINGHOUSE OF INFORMATION REGARDING VA ASSETS AND CAPABILITIES. NAVREF ALSO PURSUES AN OUTREACH PROGRAM TO HIGHLIGHT THE
